AN ACT

SEPARATING THE SITIOS OF KIMBUAYA, LONGBOY, BULALA, KINAPIAN, INDADANGAN, KUMANIBE AND MACAAG FROM BARANGAY SUYO PROPER IN THE MUNICIPALITY OF SUYO, PROVINCE OF ILOCOS SUR AND CONSTITUTING IT INTO A DISTINCT AND INDEPENDENT BARANGAY TO BE KNOWN AS BARANGAY KINAPIAN

*Be it enacted by the Senate and the House of Representatives
of the Philippines in Congress assembled:*

1 **SECTION 1. *Creation of Barangay Kinapian.*** - The sitios of Kimbuaya, Longboy, Bulala,
2 Kinapian, Indadangan, Kumanibe and Macaag in Barangay Suyo, Municipality of Suyo, Province
3 of Ilocos Sur are hereby separated from Barangay Suyo Proper in the Municipality of Suyo,
4 Province of Ilocos Sur and constituted as a distinct and independent barangay to be known as
5 Barangay Kinapian.

6 **SEC. 2. *Territorial Boundaries.*** - The territorial boundaries of Barangay Kinapian are
7 hereby described as follows:

32 **SEC. 3. *Conduct and Supervision of Plebiscite.*** – Pursuant to Section 10 Republic Act No.
33 7160, otherwise known as the Local Government Code of 1991, as amended, the new Barangay
34 Kinapian shall exist upon the approval of a majority of qualified voters of Barangay Suyo through
35 the votes cast in a plebiscite to be conducted and supervised by the Commission on Elections
36 (COMELEC) within ninety (90) days from the effectivity of this Act.

38 The expenses for the plebiscite shall be borne by the Municipality of Suyo, Province of
39 Ilocos Sur.

40 **SEC. 4. *Barangay Officials.*** - The first set of barangay officials of Barangay Kinapian shall
41 be appointed by the President of the Philippines and shall hold office until such time that the new
42 set of officers have been duly elected and qualified.

1 **SEC. 5. *Public Infrastructure and Facilities.*** - All public infrastructure and facilities existing
2 therein at the time of the approval of this Act are hereby transferred without cost or
3 compensation to and shall be administered by the new Barangay Kinapian.

4 **SEC. 6. *Internal Revenue Allotment Shares.*** - Barangay Kinapian shall be entitled to
5 Internal Revenue Allotment (IRA) shares pursuant to Section 285 of the Local Government Code
6 of 1991, as amended.

7 **SEC. 7. *Effectivity.*** - This Act shall take effect fifteen (15) days after its publication in the
8 Official Gazette or in a newspaper of general circulation.
